Call to Order

Request to amend ordinances

Requiring water and sewer

utility connections

G. Farr provided a report in support of the existing ordinances requiring water and sewer utility connections and prohibiting private septic systems. C. Hughes moved to suspend the rules to hear from the audience. C. McAllister seconded. *The motion to suspend the rules carried unanimously.* The following people spoke:

- Kathy McAllister, 4301 Milltown Road, supports changing the ordinances due to the financial burden to rural property owners who are required to connect to municipal utilities and the freedom of personal choice.
- Ken Stordeur, owner of Stordeur Sanitation, said the state requires septic inspections every three years and the systems are upkept and safe.

C. Hughes moved to return to regular order. C. Nielsen seconded. *The motion to return to regular order carried unanimously.*

The board discussed at length. R. Suennen moved to keep the existing ordinances and to add an exemption for homes located greater than 400 feet from the roadway. R. Bredael seconded. **The motion carried 7-2 (No: C. McAllister, C. Hughes).**

2019 asphalt resurfacing and other related projects

G. Farr reviewed the 2019 road resurfacing map. C. Hughes moved to award the 2019 asphalt resurfacing project to MCC Inc. for \$1,758,175.15, contingent upon attorney review of the contract. S. Beyer seconded. **The motion carried unanimously.**

Storm water management comments and report

M. Kaster reviewed the village's annual MS4 storm water management report. B. McIntyre opened the floor for public comments. Nobody spoke. J. Muraski moved to approve the Village of Howard's 2018 annual MS4 storm water management report. C. Nielsen seconded. **The motion carried unanimously.**
